Location: GI Center at Glens Falls Hospital. Patient parking is provided in the GI Lot located in the rear of the hospital, behind the Emergency Department.

Please do not arrive prior to 7:00AM. The GI Center closes in the late afternoon and patients must be picked up no later than 4:30 PM.

Planning for Your Upper Endoscopic Ultrasound (EUS) with MAC

Please read all preparation instructions.

- Arrange for a responsible adult (18 years or older) to drive you home. **You must have a responsible adult with you even if you take a taxi or use medical transport.**
- You will be receiving intravenous sedation for your procedure; this will limit what you can do after the procedure until the following day. **You may not drive or operate machinery for the next 24 hours and a responsible adult must stay with you for 24 hours following the procedure.**
- Please wear comfortable, loose fitting clothing and leave valuables at home.
- **The Glens Falls Hospital scheduling staff will call to pre-register you prior to your procedure and a nurse from Pre-admission Testing will call you to review your medical history and medications.**
- Please bring your insurance card and photo ID on the day of the exam
- You will be at the GI Center 2 ½ - 3 hours from time of arrival to discharge.

It is very important that you keep this scheduled appointment. If you must cancel or reschedule your colonoscopy appointment, please **call 518-793-5034 at least 7 days in advance**. Patients failing to cancel their colonoscopy appointment within 7 days will be billed an administrative fee of \$100 by Gastroenterology Associates of Northern NY, P.C. This fee must be paid prior to rescheduling your procedure or scheduling future appointments with our practice. If you have any questions regarding the need to cancel due to illness or other health issues, contact our office or our physician on call (after hours or on weekends)

If you have not heard from the Glens Falls Hospital scheduling staff within 24 hours of your procedure, please call 518-926-5333.

If you have not heard from a Pre-admission Testing nurse to review your medical history within 24 hours of your procedure, please call 518-926-6472 between 8 AM – 4 PM.

Medications:

- **If you are diabetic** and take oral diabetic agents, please do not take these medications on the day of your endoscopic ultrasound. If you take insulin, we will give you specific instructions for insulin the evening prior and day of your endoscopic ultrasound. If you have not received specific instructions for your diabetic medications, please call our office.

- **If you take anticoagulant medications (blood thinners) or anti-platelet medications such as:**

WARFARIN (Coumadin, Jantoven)

PRADAXA (Dabigatran)

XARELTO (Rivaroxaban)

ELIQUIS (Apixaban)

SAVAYSA (Edoxaban)

PLAVIX (Clopidogrel)

BRILINTA (Ticagrelor)

EFFIENT (Prasugrel)

PLETAL (Cilostazol)

We will give you instructions for holding these medications prior to the endoscopic ultrasound after consulting with the prescribing physician. If you have not received specific instructions from our office within 10 days of your scheduled procedure, please call our office.

- You may continue to take daily medications including aspirin and nonsteroidal anti-inflammatory medications (NSAIDs) such as Advil, Aleve, Celebrex, Bextra, Voltaren. You may also take Tylenol (acetaminophen).

PLEASE NOTE: If your insurance plan requires a referral form from you primary care physician, please confirm that our office has received the referral form to cover this procedure. If your insurance plan requires pre-authorization for this procedure, please confirm that our office has obtained the pre-authorization for this procedure.

Purchase the following liquids:

- Two (2) 20 ounce bottles of Gatorade or Powerade

*****Please avoid red, blue, green or purple Gatorade or Powerade*****

PREPARATION INSTRUCTIONS

THE DAY BEFORE YOUR UPPER EUS DAY: _____

- You may consume a normal diet the day before the exam. Your anesthesiologist wants you to drink 16-20 ounces of Gatorade or Powerade before you go to bed.
- Take nothing by mouth (no solid food or liquids) after midnight **EXCEPT** the 16-20 ounces of Gatorade or Powerade in the morning on the day of your procedure.

THE DAY OF YOUR UPPER EUS DAY _____

- Your anesthesiologist wants you to drink an additional 16-20 ounces of Gatorade or Powerade **at least two (2) hours before you arrive at the hospital.** A nurse from Pre-admission Testing will tell you what medications you may take the day of your procedure.
- **NOTHING BY MOUTH** (including water, gum, mints) after you drink the 16-20 ounces of Gatorade or Powerade.

Due to increasing number of patients with high deductible plans, all deductibles, copays and coinsurance are due five days prior to your appointment. Payment should be mailed or brought to our office at Five Irongate Center, Glens Falls, New York 12801. If our office does not receive payment within the above time frame, your procedure will need to be rescheduled.

The physician performing your procedure will have a charge, the facility where you have your procedure performed will have a facility charge and if you have a biopsy taken or polyp removed, there will also be a fee for pathology services. Most patients will undergo conscious sedation which is given by our physicians and included in the physician charge, but if you are scheduled for anesthesiologist assisted sedation, there will also be a charge for the anesthesiologist.
